7 **ORDER AMENDING**  
8 **SETTLEMENT AGREEMENT**

9 On October 5, 2010, Respondent, Ryan Mitchell, D.O., License No. 1113, requested a  
10 modification of that settlement agreement with order signed by the Board on December 8,  
11 2009. More specifically, Dr. Mitchell requested that his payment plan be modified by deferring  
12 the payments for one (1) year. In exchange for the deferment, Dr. Mitchell offered to pay  
13 interest pursuant to statute, namely, NRS 99.040. The interest will commence on December 8,  
14 2010 and will compound semi-annually until the amount owed is paid in full. Dr. Mitchell  
15 further requested that the payments remain at the agreed upon amount of \$833.33 per month,  
16 but that they shall commence on December 8, 2011.

18 AFTER DELIBERATIONS IN CLOSED SESSION, and good cause appearing  
19 therefore, IT IS HEREBY ORDERED that the payment plan previously set forth in the  
20 Settlement Agreement on file herein is hereby modified as follows: The amount due shall  
21 remain at \$15,000.00; the payments shall remain at the monthly rate of \$833.33; the  
22 payments are deferred for one (1) year, i.e., the payments shall now commence on December  
23 8, 2011; and that interest shall be charged on the amount due beginning on December 8,  
24 2010, at the legally allowable rate set forth in NRS 99.040 and compounded semi-annually.

2 Mitchell from making payments prior to December 8, 2011.
