NOTICE OF HEARING

NOTICE IS HEREBY GIVEN that a complaint has been filed pursuant to Chapter 633 of the Nevada Revised Statutes and Chapter 633 of the Nevada Administrative Code, charging you with (1) prescribing controlled substances without DEA registration, (2) for unprofessional conduct and unethical conduct due to inadequate and/or incomplete medical records pertaining to patient J.G., and (3) unethical conduct by overprescribing to patient J.G. for ailments/injuries/diseases for which the medical records do not substantiate the need for prescriptions of various controlled substances. All of such conduct may also constitute an unfitness to practice osteopathic medicine in the State of Nevada.

A photocopy of the Complaint is being served on you along with this Notice of Hearing. Notices pursuant to NRS chapter 233B have already been provided to the Respondent.

YOU ARE HEREBY NOTIFIED that a hearing before the Hearing Officer for the Nevada State Board of Osteopathic Medicine on the complaint shall commence as follows:

On the 6th day of MARCH, 2010, at the hour of 9:00 A.M., or as soon thereafter as it may be heard, and continuing on the 7th day of MARCH, 2010, if necessary, at the Offices of the State of Nevada Board of Osteopathic Medicine, located at 901 American Pacific Drive, Unit 180, Henderson, Nevada 89014.

YOU ARE FURTHER NOTIFIED that you have the right to be heard and to appear in person or by counsel and to present evidence and witnesses on your behalf at the aforesaid

1 time and place fixed for the hearing on the Complaint and charges.

2 **YOU ARE FURTHER NOTIFIED** that possible sanctions authorized in NRS 633.651
3 include:

4 Probation for a specified period or until further order of the Board.

5 A public reprimand.

6 Limitation of the practice to, or by exclusion of, one or more specified branches
7 of osteopathic medicine.

8 Suspension of the license to practice osteopathic medicine for a specified
9 period or until further order of the Board.

10 Revocation of the license to practice osteopathic medicine.

11 Fines in the amount of, and up to, \$5,000.00 per violation.

12 Supervision of the practice of osteopathic medicine.

13 The requirement of community service for no compensation.

14 Additional training and/or education requirements, and

15 Any other terms, provisions, or conditions the Board deems proper and which
16 are not inconsistent with law.

17 The Hearing Officer may award fees and costs to the Board and against you.

18 **YOU ARE ALSO NOTIFIED** that, pursuant to NAC 633.460, you and/or your attorney
19 shall meet or confer with the Board's legal counsel, and the prosecuting attorney for the
20 Board, not later than 20 days before the hearing and exchange copies of all documents that
21 each party intends to offer as evidence in support of its case, identify describe or produce all
22 tangible things, other than documents, that each party intends to offer as evidence in support
23 of its case and, if requested, arrange for the opposing party to inspect, copy, test, or sample
24 such evidence under reasonable supervision, and exchange written lists of persons that each
25 party intends to call as witnesses in support of its case as outlined in NAC 633.460 (1)(c).


26 **LASTLY, YOU ARE NOTIFIED** that your failure to attend the hearing, or your failure to
27 defend yourself, shall not serve to delay or void the proceedings pursuant to NRS 622A.350.

28 Pursuant to NRS 622A.410, if your medical license is revoked, an order may be entered by

1 the Hearing Officer "prescribing [a period of time] in which [you] may not apply for
2 reinstatement of the license. The period must not be less than 1 year and not more than 10
3 years."
