9 NOTICE IS HEREBY GIVEN that a complaint has been filed pursuant to Chapter 633
10 of the Nevada Revised Statutes and Chapter 633 of the Nevada Administrative Code,
11 charging you with (1) unprofessional conduct and (2) unethical conduct, arising from acts of
12 alleged open and public lewdness, which allegations if proven may constitute an unfitness to
13 practice osteopathic medicine in the State of Nevada.

15 **A photocopy of the Complaint is being served on you along with this Notice of**
16 **Hearing.**

17 YOU ARE HEREBY NOTIFIED that a hearing before the Hearing Officer for the
18 Nevada State Board of Osteopathic Medicine on the complaint shall commence as follows:

19 On the 9th day of January, 2010, at the hour of 9:00 A.M., or as soon thereafter as it
20 may be heard, and continuing on January 10, 2010, if necessary, at the Offices of the State of
21 Nevada Board of Osteopathic Medicine, located at 901 American Pacific, Suite 180,
22 Henderson, Nevada 89014.

24 YOU ARE FURTHER NOTIFIED that you have the right to be heard and to appear in
25 person or by counsel and to present evidence and witnesses on your behalf at the aforesaid
26 time and place fixed for the hearing on the Complaint and charges.

27 YOU ARE FURTHER NOTIFIED that possible sanctions authorized in NRS 633.651
28 include, but are not limited to:

- 1 A. Probation for a specified period or until further order of the Board.
- 2 B. A public reprimand.
- 3 C. Limitation of the practice to, or by exclusion of, one or more specified branches of
- 4 osteopathic medicine.
- 5 D. Suspension of the license to practice osteopathic medicine for a specified period
- 6 or until further order of the Board.
- 7 E. Revocation of the license to practice osteopathic medicine.
- 8 F. Any other terms, provisions, or conditions the Board deems proper and which are
- 9 not inconsistent with law.

10 Fines may also be assessed against you for each violation proven; and the Hearing
11 Officer may award fees and costs to the Board and against you.


12 YOU ARE ALSO NOTIFIED that, pursuant to NAC 633.460, you and/or your attorney
13 shall meet or confer with the Board's legal counsel, and the prosecuting attorney for the
14 Board, not later than 20 days before the hearing and exchange copies of all documents that
15 each party intends to offer as evidence in support of its case, identify describe or produce all
16 tangible things, other than documents, that each party intends to offer as evidence in support
17 of its case and, if requested, arrange for the opposing party to inspect, copy, test, or sample
18 such evidence under reasonable supervision, and exchange written lists of persons that each
19 party intends to call as witnesses in support of its case as outlined in NAC 633.460 (1)(c).

20 LASTLY, YOU ARE NOTIFIED that your failure to attend the hearing, or your failure to
21 defend yourself, shall not serve to delay or void the proceedings pursuant to NRS 622A.350.
22 Pursuant to NRS 622A.410, if your medical license is revoked, an order may be entered by
23 the Hearing Officer "prescribing [a period of time] in which [you] may not apply for
24

1 reinstatement of the license. The period must not be less than 1 year and not more than 10
2 years."
