**NOTICE OF PUBLIC WORKSHOP FOR PROPOSED
REGULATIONS FOR THE NEVADA STATE BOARD OF OSTEOPATHIC MEDICINE
LCB File No. R093-11 Administrative/Licensing and R094-11 Telemedicine**

The Nevada State Board of Osteopathic Medicine ("Board") is proposing an Adoption of regulations pertaining to chapter NRS 633 of Nevada Administrative Code. A workshop has been set for December 13, 2011 commencing at 6:00 p.m. following the Board Meeting, at its office located at 901 American Pacific Dr., Suite 180, Henderson, Nevada 89014. The purpose of the workshop is to solicit comments from interested persons on the following general topics that may be addressed in the proposed regulations:

1. **Revision to NAC 633.255 and NAC 633.270 regarding Administrative changes (R093-11).**
2. **New language regarding proration of initial licensing fees (R093-11).**
